2. Producer may solicit other Exhibitors in the same category to participate in the Jstyle WEDDINGS Bridal Event.
3. Producer will reserve above selected exhibit space for the Exhibitor's use for the Jstyle WEDDINGS Bridal Event.
4. Exhibitor is responsible for erecting, supplying, and staffing the exhibit space specified above, during all hours of the event, and is subject to the rules and regulations of Producer and The Westin Cleveland Downtown.
5. Payment is due at the time of signing Exhibitor agreement. Producer is not obligated to refund any part of the exhibitor's fee for any reason after signing this Agreement. If for any reason payment is not made in full within two weeks of the show date, Exhibitor agrees that the Producer may charge their credit card for the full amount due to the Producer. Exhibitor further agrees to pay all attorney fees, collection fees, court costs, interest and any other expense incurred by Producer to enforce the terms of this contract against the Exhibitor.
6. Exhibitor will not sublet, share, re-assign space, or distribute another company's literature.
7. Producer has the right to remove and/or ban Exhibitor for just and reasonable cause at any time during the event.
8. Producer reserves the right to move Exhibitor's location at event if necessary.
9. All displays and hanging of displays/props on walls and from ceilings must be approved by Producer and The Westin Cleveland Downtown prior to set up. Producer and The Westin Cleveland Downtown assume no liability for Exhibitor equipment.
10. Producer and The Westin Cleveland Downtown assume no liability for the criminal actions of third parties to any Exhibitor or Exhibitor's equipment.
11. Exhibitor is required to carry liability insurance.
12. Investment is non-refundable if event is effected by any unforeseen circumstance beyond the control of the Producer.
